

## Conservation Compliance Producer Look-up Service

RMA has developed a Conservation Compliance eligibility lookup feature that companies can host in their own applications as a real-time solution to quickly look-up a customer (or prospective customer) for premium subsidy eligibility. The tool is completely optional for AIPs to use. The underlying data used is the most current list of producer status provided by FSA and does not take into account pending manual additions or producers who may be eligible for Certification Statements available through PM-15-032 - RMA Conservation Compliance Procedures.

### AIP Conservation Compliance Endpoint Tip Sheet

- AIP Conservation Compliance Endpoint is a REST based Web Service.
- AIP Conservation Compliance Endpoint uses Client side Certificate Authentication.
- If not already setup for ACRSI or RLUs, an AIP needs to provide a Certificate Signing Request (CSR) created for Client Authentication to RMA. Please note again the CSR should be for Client Authentication. RMA will sign it and send the certificate back to the AIP. The AIP can reach out to RMA Web Support team – (816) 926-7301 for any questions on the CSR for AIP Conservation Compliance Service.
- RMA must open a network port so that the AIP can access the URL.

### Usage

- The service end point requires TaxId, TaxIdTypeCode, and ReinsuranceYear as part of the request body via HTTP POST (refer to sample raw post request).
  - TaxId is 9 digit alpha-numeric (no dashes).
  - TaxIdTypeCode is 1 digit alpha-numeric (1 = SSN, 2 = EIN).
  - ReinsuranceYear is 4 digit numeric (currently, only 2016 year data is available).
- The return value is “Eligible” and “Not Eligible” for the inputted Reinsurance Year.
  - “Eligible” currently means certified AD-1026 found and no PCW violation.
  - “Not Eligible” means certified AD-1026 found and a PCW violation exists.
  - “Not Found” means no record found (no certified AD-1026 on file).
