2023 Reinsurance Year

The SCO, ECO, STAX, and Margin Protection plans are charged a separate administrative fee.

- ** High Risk Land may be insured under CAT or HR-ACE, and the remainder of the commodity may be insured under buy-up, therefore, more than one fee would apply in these situations. HR-ACE commodities include wheat, corn, cotton, grain sorghum and soybeans.
- *** Cotton with the cottonseed endorsement shall be charged 2 admin fees. When HR-ACE also applies then a separate set of Administrative Fees will apply.
- **** PRF with 2 different plans will have two administrative fees.
- ***** HIP-WI Endorsement will have one Admin Fee per Crop/County Policy (e.g., HR-ACE or otherwise required per the Basic Crop Provisions of the specific crop that creates another Crop Policy within the county).

For HIP-WI endorsements that cover cotton with the cottonseed endorsement will only have one admin fee.

^{*} More than one fee may be charged if the commodity can be insured under more than one plan in the county.
