Record Notes:

1 A P57A is only required for the specific record(s) that had changes as a result of the QC review, and not for each of the "cascading" changes that occur on the ECIC as a result of the record changes specifically made for the QC Review. For example, on a QC review of prior APH history where one annual yield was changed on the P15A, you need only report a single P57A for that P15A and not for the subsequent changes to the P15, P11 and P21 as a result of making that change to the P15A.
