		3							The parent Policy Producer, "P10" record must exist for the Policy Producer Address, "P10A" record to be accepted.
		4							The parent Policy Producer, "P10" record must be free of errors for the Policy Producer Address, "P10A" record to be accepted.
		5							A Policy Producer "P10" record, must be accepted before a Policy Producer Address, "P10A" record, will be accepted.
