

Resource Land Unit (RLU) Overview

RMA has developed the capability for AIPs to submit geospatial data for insurance purposes called the RLU. RLUs do not replace Common Land Units (CLU) as they are a specialized and complementary data layer that should reflect a more accurate planted field boundary than the existing CLU. Data will be submitted to the RMA in the GeoJSON format using a web service. Submitted RLU's will be validated and accepted RLUs will be given a unique RLU ID. Rejected RLUs will be given an error code and all accepted and rejected RLUs will be returned to the submitting AIP through a service in the JSON format.

RLU File Format

The RLUs are to be submitted as a GeoJSON, a formatted text string of coordinate points representing the bounding shape of a polygon with required and optional attribution. Multi-part polygons will not be accepted. (<http://geojson.org/>)

Coordinate System/Datum

GeoJSON's are to be submitted in a geographic coordinate reference system, using the WGS84 datum, and with a longitude and latitude units of decimal degrees.

AIP RLU Intake Endpoint

- AIPRLU Intake Endpoint is a REST based Web Service.
- AIPRLU Intake Endpoint uses Client side Certificate Authentication.
- AIP needs to provide Certificate signing Request (CSR) created for Client Authentication to RMA. Please note again the CSR should be for Client Authentication. RMA will sign it and send the certificate back to AIP. The AIP can reach out to RMA Help Desk – (816) 926-1126 for any queries on CSR for AIPRLU Intake Service. **(Note: If your organization has already completed this step as part of the ACRSI project, this step does not have to be repeated unless a different set of servers is used to communicate with RMA)**
- The service end point accepts RLU report JSON as part of Request body via HTTP POST (refer to sample raw post request).

AIP Service Endpoint

- AIP Service Endpoint for receiving RLU Reports should be REST based.
- The AIP service end point should accept file as part of Request via HTTP POST (refer to sample raw post request).
- The RLU JSON Report key name is “file” (refer to content disposition in the sample raw post request)
- File Name will be unique per the following format
AIPRLU_<AIPCODE>_<INTERNALIDENTIFIER>_<DDMMYYYY>.json for
example AIPRLU_AA_1234_06152015.json
