#### General

**Acreage Limitation:** In accordance with Section 9 of the ARH Strawberry Pilot Crop Provisions, the insured acreage for the current crop year will be limited to 125 percent of the greatest strawberry acreage grown in any of the 3 preceding crop years, unless this limitation is waived by the RMA Regional Office or if the increase is 10 acres or less. The insurable number of acres will be calculated by multiplying the greatest number of acres you planted in any of the 3 preceding crop years by 1.25. This number of acres will be included on the acreage report as insurable. All acres exceeding this amount must be reported as uninsured. The value of production to count will be reduced as described in the ARH Strawberry Pilot Crop Provisions.
