In accordance with section 10(a) of the Clary Sage Crop Provisions and provided all other policy requirements for a replant payment are met, a replant payment may be made when the crop is damaged to the extent there are less than 2.0 remaining live plants per linear foot of row when the crop is planted in row widths 20 inches or more, or there are less than 6.0 remaining live plants per square yard when the crop is planted in row widths less than 20 inches.
