In accordance with Section 14(b)(4)(ii) of the crop provisions, the percentage for catastrophic risk protection will be fifty-five percent.

#### Type

- \*4 Traditional Round/Globe Definition: Field grown mature green or ripe fresh market tomatoes that meet the Agricultural Marketing Service United States Standards for Grades of Fresh Tomatoes and the applicable Federal Marketing Order.

#### Date

- \*5 In accordance with section 10 of the Crop Provisions, the end of insurance date will be no later than the date specified in the actuarial documents.

#### Price

The maximum amount of the replanting payment per acre will be \$590.00

See the prices tab for allowable costs, minimum value, and minimum value option prices.

Allowable cost is not allowed for u-pick, penhooking and direct marketing.

#### Insurance Availability

Any acreage in this county without a rate or designated as uninsurable or unclassified on the actuarial map will be insurable only by written agreement, unless such acreage is otherwise classified in the actuarial documents. Contact your crop insurance agent by the sales closing date to determine eligibility requirements.
