#### Statement

##### General

Contact your agent regarding possible premium discounts, options, and/or additional coverage that may be available.

Per the crop provisions, the maximum percent of value allowed in any one index interval is 40%.

In accordance with the Basic Provisions, the administrative fee is \$30.

- \*4 Growing Season 1 means annual forage planted on or after July 16 and on or before October 15 of the same crop year, with available index intervals from September 1 through March 31 of the same crop year.
- \*5 Growing Season 2 means annual forage planted on or after October 16 and on or before January 15 of the same crop year, with available index intervals from December 1 through June 30 of the same crop year.
- \*6 Growing Season 3 means annual forage planted on or after January 16 and on or before April 15 of the same crop year, with available index intervals from March 1 through September 30 of the same crop year.
- \*7 Growing Season 4 means annual forage planted on or after April 16 and on or before July 15 of the same crop year, with available index intervals from June 1 through November 30 of the same crop year.

Veteran Farmer or Rancher - An individual who served in the active military, naval, or air service in the Armed Forces, and was discharged or released under conditions other than dishonorable, and: has not operated a farm or ranch; has operated a farm or ranch for not more than five years; or is a veteran who has first obtained status as a veteran during the most recent five-year period. A person other than an individual may be eligible for veteran farmer or rancher benefits if there is at least one individual substantial beneficial interest holder and all substantial beneficial interest holders qualify as a veteran farmer or rancher, unless the substantial beneficial interest holder is a spouse. A spouse's veteran farmer or rancher status does not impact whether an individual is considered a veteran farmer or rancher.

In lieu of section 11(h) of the Basic Provisions you will be ineligible for any premium subsidy paid on your behalf by FCIC for any policy issued by us if:

1. USDA determines you have committed a violation of the highly erodible land conservation or wetland conservation provisions of 7 CFR part 12 as amended by the Agricultural Act of 2014; or
2. You have not filed form AD-1026 with FSA for the reinsurance year by the premium billing date.
  - i. Notwithstanding section 11(h)(2), you may be eligible for premium subsidy without having a timely filed form AD-1026:
    - A. For the initial reinsurance year if you certify by the premium billing date for your policy that you meet the qualifications as outlined in FCIC approved procedures for producers who are new to farming, new to crop insurance, a new entity, or have not previously been required to file form AD-1026; or
    - B. If FSA approves relief for failure to timely file due to circumstances beyond your control or failure to timely provide adequate information to complete form AD-1026 in accordance with the provisions contained in 7 CFR part 12.
  - ii. To be eligible for premium subsidy paid on your behalf by FCIC, it is your responsibility to assure you meet all the requirements for:
    - A. Compliance with the conservation provisions specified in section 11(h)(1) of this section; and
    - B. Filing form AD-1026, or successor form, to be properly identified as in compliance with the conservation provisions specified in section 11(h)(1) of this section.

#### Insurance Availability

Acreage that has not been planted or insured (including insured acreage that was prevented from being planted) in at least one of the three previous crop years is insurable if the policyholder certifies and has documentation that the new breaking acreage was tilled or chemically destroyed on or before the Sales Closing Date prior to planting.

- \*11 By the Acreage Reporting Date, Producers may elect to insure their crop using the dual use option which allows the producer to purchase both an Annual Forage Policy and a Small Grains Crop Policy. Annual Forage Commodities covered under the Small Grains Crop Provisions that offer a short rate and that is planted with the intent of grazing the crop first and then later harvesting the crop for grain will be eligible for the dual use option and producers will be able to retain both benefits.
