Birdsfoot Trefoil/Grass Mixture: Normal planting density is 8.0 birdsfoot trefoil plants per square foot.

Birdsfoot Trefoil: Normal planting density is 12.0 birdsfoot trefoil plants per square foot.

*4 Alfalfa 90-100: A minimum of twelve (12) live plants per square foot will be considered to be a normal planting density for replant purposes.

*5 Alfalfa 60-89: A minimum of eight (8) live plants per square foot will be considered to be a normal planting density for replant purposes.

- *8 Alfalfa 60-89: Alfalfa is at least 60 percent but less than 90 percent of groundcover.
- *9 Birdsfoot Trefoil/Grass Mixture: A mixed stand of birdsfoot trefoil and grass in which birdsfoot trefoil comprises more than 25 percent but less than 60 percent of the ground cover.
- *10 Birdsfoot Trefoil: A pure stand of birdsfoot trefoil or a stand of birdsfoot trefoil and grass in which 60 percent or more of the ground cover is birdsfoot trefoil.

Date

As provided in section 9(c) of the Forage Seeding Crop Provisions harvest of the forage after August 15 of the crop year will end the insurance period.

Insurance Availability

Insurance shall attach to a crop following a cover crop when the cover crop meets the definition provided in the Basic Provisions, was planted within the last 12 months, and is managed and terminated according to NRCS Cover Crop Termination Guidelines. The Guidelines include information on cover crops and crop insurance, Good Farming Practices for cover crops, and termination information and exceptions, which can be found at <https://www.rma.usda.gov/en/Topics/Cover-Crops>.
