Type

- *3 Insurable Varieties for Group B: All other varieties not specified in Group A.

Date

The production reporting date for spring practice will be the spring acreage reporting date. The production reporting date for summer practice will be the summer acreage reporting date.

- *5 In lieu of section 6(a)(2) of the Basic Provisions, you must submit your acreage report on or before the acreage reporting date contained in these Special Provisions of Insurance.
- *6 Insurance will attach only on potatoes planted during the period of June 10 - August 1.
- *7 Insurance will attach only on potatoes planted during the period of February 15 - May 15.
- *8 Insurable variety for Group A: Russet.

In lieu of the definition of late planting period in section 1 of the Basic Provisions, please refer to the End Of Late Planting Period Date.

Price

If a contract price is available as shown in the actuarial documents, you may elect to have your price election determined in accordance with the Contract Price Addendum (CPA). If the crop provisions or special provisions provide a method to determine a contract price your price election will be determined in accordance with the crop provisions or special provisions and the CPA does not apply.

Premium

Any acreage in this county with a high risk area designation on the actuarial map will have a rate adjusted in accordance with the high risk area and map area rates table.

Insurance Availability

Insurance will not attach to any acreage on which potatoes were planted the preceding year unless the land was properly treated with a nematicide/insecticide according to approved Extension Service recommendations prior to planting potatoes.

Insurance will not attach to any acreage on which potatoes were planted the preceding crop year except for the following islands and tracts located in the Delta area: That portion of 'Staten Island located in Township 3N, all of Terminous Island, Bouldin Island, Upper and Lower Jones Tract, Shima Tract, King Island, Empire Tract, Mandeville Island, McDonald Tract, Rindge Tract, Bacon Island and the portion of Roberts Island west of Inland Drive and the portion of Victoria Island north of Highway 4.

In accordance with section 8 of the Basic Provisions, insurance shall not attach to varieties of the fingerling type, unless provided by written agreement.

Insurance shall attach to a crop following a cover crop when the cover crop meets the definition provided in the Basic Provisions, was planted within the last 12 months, and is managed and terminated according to NRCS Cover Crop Termination Guidelines. The Guidelines include information on cover crops and crop insurance, Good Farming Practices for cover crops, and termination information and exceptions, which can be found at <https://www.rma.usda.gov/en/Topics/Cover-Crops>.

Quality

With regard to Grade Inspections and the respective U.S. Grade Standard (i.e. Processing, Chipping, Seed and all other Potatoes), the only size modifications recognized are those instituted by State or Federal Marketing Orders.
